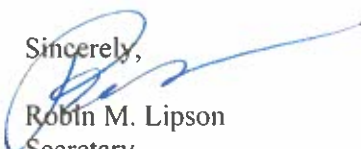
The Executive Office of Elder Affairs (EOEA) has completed the biennial compliance review of Atria Longmeadow Place Assisted Living in response to your submission of an application for re-certification as an Assisted Living Residence as set forth in 651 CMR 12.03(4) et seq. Based on this review, EOEA has determined that all findings identified during the compliance review on August 8, 2024 have been sufficiently addressed through the submitted plan of correction and that Atria Longmeadow Place Assisted Living meets all the requirements established in 651 CMR 12.00 et seq. to operate and maintain an Assisted Living Residence.

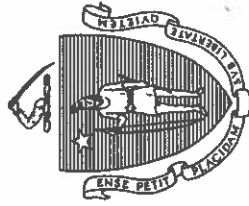
The enclosed is a certificate to operate and maintain a 110-unit Assisted Living Residence comprised of one 13-unit Special Care Residence as described on the enclosed certificate. The certificate is valid until September 14, 2026. Please note the requirements established in 651 CMR 12.03(9) regarding posting of the certificate in the Residence and non-transferability of Certification.

If during the certification period EOEA determines documents submitted in compliance with the regulations require modification or supplementation, it will so notify the Residence and will include a deadline for provision of the information needed to retain certification. Also, if there are any material changes to the operating plan, you are required to notify EOEA at least 30 days prior to the effective date of changes. In addition, the financial disclosure form developed by EOEA must also be completed and submitted annually within 90 days following the end of the Assisted Living Residence's fiscal year.
